On Baltimore County Solid Waste Management

- a. As of July 1, 2016, there are 337,439 housing units in Baltimore County.
- b. The main landfill in use by Baltimore County was opened in 1982 and has a lifespan to 2052.
- c. Reasons to Recycle
  - a. Conserves natural resources
  - b. Saves energy
  - c. Reduces pollution
  - d. Creates jobs
  - e. Saves money
  - f. Lengthens landfill life.
- d. Baltimore County pays \$64 a ton for landfill.
- e. [www.bcrecycles.com](http://www.bcrecycles.com) website provides much information on recycling.
- f. Baltimore County doesn't supply recycle bins, (estimated cost would be \$8m) but future "Single Single Stream" efforts may require special bins that could be paid for by the county or its customers. This approach is garbage, trash, and recyclables in one can.
- g. The county promotes "reuse" and provides a handout of places and items they accept.
- h. Paint will now be accepted at Cockeysville.
